PDMP Data, Central Oregon, 1/2015-08/2015

• In Oregon, about 1 in 4 people have a controlled substance prescription

Use of the Prescription Drug Monitoring Patient Report

- Check the patient report at first visit, when writing a new or renewal prescription for a controlled substance, periodically
- Use the patient report to connect with other providers who are writing controlled substance prescriptions for a patient
- Use the patient report to discuss patient controlled substance use with a patient
- Use the patient report as part of assessment

Increase Opioid Prescriber Registration in a Clinical Setting

- Assess the registration rate in a setting
- Set a target for registering 90% prescribers by end of 2015
- Establish registration site in setting
- Distribute registration forms to staff that agree to register
- Collect completed registration forms from staff
- Set up a time for a notary to come to the office during a staff meeting
- Staff can show credentials and notary can sign off on registration forms
- Send forms to the PDMP office in Portland



Delegates

- Staff that work with authenticated registered users of PDMP can also become system users
- They have to complete registration forms in the same way as prescribers or pharmacists
- Prescribers and pharmacists are responsible for managing the delegate accounts working in their practice

- Registration is a two step process that includes online setup and download and completion of a notarized registration form
- PDMP needs assistance increasing prescriber and pharmacist registration to 90% statewide
